Item 1 Welcome and competition policy

Jo welcomed all and introductions completed.

Glen drew the attention of the meeting to the GS1 Competition policy.

Item 3 Apologies for absence and acceptance of previous meeting minutes

Item 4 MHRA update

Bayode updated the meeting on the forthcoming Med and IVD changes from Jan 2021(following Brexit) inc the Medicines and Medical Devices Bill as well as the IMMDS.

Bayode. The UK will continue to recognise the CE Mark until 30/06/2023.

The UKCA (UK Conformity Assessed) mark, a new UK product marking that will be used for goods being placed on the market in Great Britain (England, Wales and Scotland), which covers most goods which previously required the CE marking can be used from 01/01/2021 and becomes mandatory from 01/07/2023.

Item 5 Workstream reports

a. **Sustainability** – NHSE zero carbon strategy has been published and one Task and Finish Group is sustainable procurement and Neil Hind (NH) sits on this group – focus includes energy, fleet, food, single use plastic and re-use of medical devices. There is more carbon from pharmaceuticals than anywhere else.

b. Traceability of Instruments- documentation being reviewed and feedback to be presented to the next HUG meeting.

c. Web Based Recall – Awaiting to see if there are any levers from the forthcoming regulations.
